2005 Facilitated adult son's relocation and supported him for one year until he established himself with employment and a home

2004 Saved my dad's life by organizing a medical intervention

1999 Gave my 2nd husband a vehicle when we separated due to his anger issues

1997 Took in Foster daughter and took on parental role in her addiction recovery

1995 Supported husband through 2 years of unemployment after his firing from a County job

1994 Participated in a drug intervention for my husband's best friend
